## CERTIFICATE OF AUTHORIZATION FOR THE SALE OF CHOMETZ

I \_\_\_\_\_ (please print name) attest that I/we, the undersigned, hereby grant the full authorization to **Rabbi Mendel Kaplan** of Thornhill, Ontario, Canada, to act on my/our behalf and in my/our place and stead, to sell to a non-Jew, all and every type, nature and kind of *chometz* which I/we or any of us may own, have any interest in or which may be in my/our possession, directly and indirectly, prior to the onset of the prohibitions against benefiting from *chometz* (leaven) as prohibited by Biblical and Rabbinic law on *Erev Pesach* of this year, Friday, Nissan 14, (April 19) before 10:59 a.m..

This includes without limitation, all and every type of food, drinks, medications, substances or ingredients that are in the category of *chometz* or possible *chometz*, or contain blends of *chometz* or even possible blends of *chometz* with even the smallest percentage of *chometz*; and include all of the utensils which have *chometz* substance on them or adhered to them.

Without limiting the generality of the foregoing, such *chometz* items may include: (please check the items applicable to your sale).

- Grouts, bran, coarse bran or starch
- Grains, flours, fine flours and yeast
- Breads, crackers & cereals
- all types of Pasta's
- Vodka, beer, whiskies and other types of grain based alcohol
- Cake, cookies, pretzels and chips
- Frozen dough's and pastries
- Food colorings, sweeteners, flavorings and other additives
- Perfumes, and other liquid cosmetics containing grain alcohol
- Food supplements and medications
- Pet foods (e.g. birds feed, fish nourishment, cat & dog food etc.)
